1 Introduction and Appointment

Please be advised that I, Dermott Joseph McVeigh, of Avior Consulting Pty Ltd (Perth, Western Australia), was appointed Liquidator of the Company on 15 April 2020 at 3:40pm by a special resolution of the sole shareholder pursuant to section 241(2)(a) of the Companies Act 1993 (the Act).

Set out below is the First Report to Creditors on the State of the Affairs of the Company as required by section 255(2)(c)(ii)(A) of the Act.

2 Restrictions

This report has been prepared for the sole purpose of reporting on the state of affairs with respect to the Company and the conduct of the liquidation.

This report is not intended for general circulation, nor is it to be reproduced or used for any purpose without my written permission. I have not independently verified the accuracy of the information provided to me and have not conducted any form of audit in respect of the Company. Accordingly, I express no opinion on the reliability, accuracy or completeness of the information provided to me and upon which I have relied.

I, my employees, agents and advisors do not assume any responsibility or liability for any losses occasioned to any party for any reason including as a result of the circulation, publication, reproduction or use of this report.

I reserve the right (but will be under no obligation) to review this report and, if considered necessary, to revise the report in light of any information existing at the date of this report which becomes known to me after that date.

4 Background

The Company was placed into liquidation due to an unresolved dispute with the New Zealand Department of Corrections in relation to a major contract. The contract was terminated, resulting in significant losses being incurred by the Company. The directors and shareholder concluded that the Company could not continue trading and proceeded to have the Company wound up.

5 Statement of Affairs

A Statement of Affairs showing the Company's estimated financial position as at the date of liquidation is enclosed at **Annexure A**. The statement has been prepared in accordance with section 255 of the Act.

6 List of Creditors

A list of all known creditors has been compiled based on the information available to me and is enclosed at **Annexure B**. For privacy reasons, the addresses of employees have been omitted from the list.

7 Declaration of Independence, Relevant Relationships and Indemnities

Attached as **Annexure C** is a copy of my Declaration of Independence, Relevant Relationships and Indemnities. I have not identified any matters that would prevent me from accepting the appointment as Liquidator of the Company.

8 Proposals for Conducting the Liquidation

I will be attending to the following matters during the course of the liquidation:

- realisation of the Company's assets;
- determination and admittance of creditors' claims;
- investigations into the affairs of the Company and the conduct of the directors;
- consideration of the prospects of recoveries from voidable transactions (if any) and breaches of directors' duties (if any);
- consideration of other actions that may be available for the benefit of creditors;
- pursue recoveries and other actions and litigation for the benefit of creditors;
- prepare reports to creditors and relevant authorities as required.

I will write to creditors again to advise the outcome of my investigations.



9 Trading

The Company ceased trading prior to my appointment.

9.1 Personal Property Securities Act / Reservation of Title

Should any creditor believe they have registered a Purchase Money Security Interest (**PMSI**) on the Personal Property Securities Register (**PPSR**) over any goods, or proceeds from realisation for goods, they should contact my office immediately.

If any creditor believes they have a Reservation of Title over goods and they have not registered their interest on the PPSR, they should also contact my office, as should suppliers of consignment or sale or return stock.

9.2 Contracts / Agreements

As Liquidator, I expressly refrain from personally adopting any of the Company's contracts existing at the date of his appointment. All contracts will be reviewed and I will advise the parties directly about the status of their contracts as soon as practicable.

10 Creditors Meeting

At this stage, it is too early to consider holding a creditors meeting as the information relevant to answering the queries of creditors is still being compiled. Once sufficient information is available and the state of the company's affairs becomes clearer, I will reconsider whether convening a meeting of creditors is appropriate.

Accordingly, under section 245 of the Act, I consider at this stage that no such meeting will be convened. A notice of my decision to dispense with the meeting of creditors is provided at **Annexure D**.

A meeting will not be called unless within 10 working days after receiving this notice, a creditor gives notice in writing to the liquidator requiring a meeting to be called.

In accordance with section 314 of the Act, a creditor or a shareholder may request the Liquidator to call a meeting of creditors or of shareholders at any time during the course of the liquidation:

- a) to vote on a proposal that a Liquidation Committee be appointed to act with the liquidator: and
- b) if it is decided to have a Committee, to choose the members of the Committee.

Any such request must be made in writing.

11 Liquidation Committee

In accordance with section 314 of the Act, a creditor or shareholder may request the Liquidator to call a meeting of creditors or shareholders at any time during the liquidation to



vote on a proposal that a Liquidation Committee be appointed to act with the Liquidator. This request must be in writing.

The Liquidator may decline a request by a creditor or a shareholder to call a meeting on the grounds that:

- a) the request is frivolous or vexatious; or
- b) the request was not made in good faith; or
- c) the costs of calling the meeting would be out of proportion to the value of the Company's assets.

The decision to decline a request may be reviewed by the Court on the application of any creditor or shareholder.

I do not consider a committee to be necessary in relation to this liquidation at this time. I will continue to report to creditors on the conduct of the liquidation as appropriate.

12 Creditors' Claims

Attached as **Annexure E** is a notice to creditors to prove their debts or claims by 15 May 2020.

Also enclosed is a claim form for completion by unsecured creditors.

Should you consider you are a secured creditor of the Company, please contact my office and I will supply to you a secured creditor's valuation and claim form.

Completion of your claim should be given your urgent attention. If creditors do not lodge their claim with the Liquidator, they are not entitled to share in any distribution to creditors that may be made.

13 Estimated Outcome for Creditors and Date of Completion

It is currently too early to estimate a date of completion for the liquidation or the likelihood of a dividend being paid to creditors.

14 Further Information

Should you have any further information that would assist my investigations, you are requested to provide this information to me in writing, attaching any supporting evidence.

Specifically, please provide details on the following issues:

- any demands, writs, judgements or other legal action taken by you against the Company;
- copies of correspondence sent to and received from the Company regarding unpaid accounts; and
- advise when trading first commenced with the Company.
